MG General Training Program Updated News Release

Are you thinking about a unique gift idea for the gardener in your family? Why not give a gift that continues long after the holidays? A limited number of seats are available for the UW-Extension Master Gardener training program according to Greg Blonde, Waupaca County UW-Extension Agriculture Agent. The training program runs twelve consecutive Tuesday evenings beginning February 7th, 2017 at the courthouse in Waupaca.

According to Blonde, "Master Gardener volunteers are local residents with an interest in gardening or landscaping who participate in the UW-Extension training program covering a broad range of horticulture topics from fruits, flowers, vegetables, lawn care and landscaping to annuals and perennials, insect, weed and disease management, and even backyard wild life. In addition to the training, Master Gardener's agree to provide volunteer support to the local UW-Extension Master Gardener association. Fortunately, Waupaca County has a very active local UW-Extension Master Gardener Association with many volunteers who provided several thousand hours of time to locally approved projects, including organization and support for children's gardens, growing produce for local food pantries, hosting their annual spring plant sale, helping with plant science exhibits at the county fair, or giving presentations to community groups on a topic of personal interest or expertise."

To become a local UW-Extension Master Gardener volunteer, participants complete 36 hours of instruction (including group classes, as well as one-line lessons from home), pass a take-home written exam, and then contribute at least twenty-four hours of volunteer service each year in support of the groups various community projects. Master Gardener volunteers also complete at least ten hours of continuing education each year, often included with the groups monthly local meetings (hled the second Thursday of each month).

Registration for the training program is \$75.00 per person, and includes a training manual. Class size is limited, so registration

will be accepted first-come, first-serve. The brochure and registration form are available at the Waupaca County UW-Extension Office at the courthouse in Waupaca, or on-line at http://waupaca.uwex.edu. The registration deadline is Monday, January 9th.
