For good and valuable consideration, receipt of which is hereby acknowledged, I the undersigned parent or legal guardian on behalf of the minor Participant, hereby hold harmless, release, waive, discharge and covenant not to sue or bring claim against Future Bucks LLC (owner and operator of the National Basketball Association G League ("NBAGL") team known as the Wisconsin Herd (the "Herd")), Fox Valley Pro Basketball, Inc., the NBAGL and its Member Teams, and their respective parents, subsidiaries, affiliates, directors, officers, governors, employees and agents (the "Released Parties") from and against any and all claims, causes of action, or demands relating to or arising out of my participation with the Wisconsin Herd to take place at the Menominee Nation Arena on the following date(s):
