State Representative Pat R. shared the WIMGA Newsletter and provided an update on the annual (virtual) face-toface meeting being held on Thursday, December 2, 2021 from 6:30-8:30 pm. Ideas for volunteers, educational information, photography, artists and social interest were shared. 2022 WCMGV Committees sign-up sheet was circulated. Project Approval and Budget Request forms were available for those who signed up to be a Chair on a Committee to set aside funds. These need to be returned for review and approval (preferably by end of year). Also, payment vouchers were provided and will be available upon request. There are still many openings and all members are encouraged to sign up during the Christmas party.

Under New Business:

ThedaCare Garden – Christie with the UW Extension office will be meeting with Debbie on December 6th to talk about a grand being written for funds. They are looking to have a Master Gardener Volunteer work on the project (written into the grant). This garden is located near the old Riverside elementary school.

New Logo – With her background in graphic arts and Information Technology, Jennie presented a new logo design option she created for a 2022 Waupaca County Master Gardener Logo. She has secured two domains (public/private) for the WCMGV association. These can be developed to gain access for public events and member's only access (login and password protected). Creating a refreshed Facebook account is also an area Jennie would like to work on. After member review and approval from the Executive Board Members, these options can be developed further. Christmas Party – A suggestion was put forth by Rebecca (w/Connie) to provide broasted chicken (catering service) for this event. Members would be encouraged to bring a side dish to pass. A motion was initiated by Carrie E. and second by Jennie E. The motion was discussed further with one member in opposition. Motion carried.
