
September Membership Meeting - Potluck at Deana's!

Meeting Minutes

August 11th, 2021, 6:30 p.m. Mulroy Farm, New London, WI

President Carrie Esch called the meeting to order.

The Secretary's report was provided by Nancy Sonnenberg. The July meeting minutes were taken by Jean Skewes in Nancy's absence and posted in the August newsletter. No corrections were noted. A motion to accept the July minutes was requested. Motion moved by Deana and second by Joan.

The Treasurer's report was provided by Rebeca Weber Schmoll and will be filed for audit. An overview of the annual budget and comparison of MGV fundraising effort and events was discussed.

Statewide Rep. Pat Ritchie reported no news or updates were provided. A notable person, Biron Hacker a state treasurer and MGV in Chilton passed this summer (74 years old).

President Carrie Esch provided an update on the latest communication with membership on-boarding, log in, canvas and entering of hours. Those who have a Net ID are encouraged to enter continuing education and volunteer hours. If posting volunteer hours under the Waupaca County Master Gardener group, use Carrie Esch as the contact person. If you need to help to complete the on-boarding there are options to do paper testing (must be loaded on to the computer) or get a Net ID and need help, please follow up with someone (ex. Carrie, UW helpdesk-Net ID).

Committee Updates:

Waupaca County Fair – The fair is under new management this year and the organization is a concern. The schedule was reviewed with openings at each timeslot. The sign-up sheet was provided to members in attendance. Pat expects to receive fair passes for volunteers on Wednesday, fair opens at 3:00pm. Garden Walk and Art Stroll – Members continued the discussion from last meeting regarding the option of holding the event every other year, rather than every year. Concerns regarding Waupaca County residence and MGV member's interest in having garden listed in 2023, return on investment and member participation were mentioned. A vote on the subject was requested to get a consensus from all members. Vote to be coordinated and formal ballots provided. Also, MGV continued membership assessment will need to be considered. Sue Morack is willing to continue to chair the committee in 2023. A decision on the event is needed by December.

Plant Sale – Rebecca Weber Schmoll and Jean Skewes are willing to co-chair in 2023. Members are asked to consider having this event every year or every other year, alternating with Garden Walk & Art Stroll. This generates the largest contribution to the association funds. Include this in the on ballots for a Membership vote. More discussion is needed with input from all members to determine how often events can be held.
